

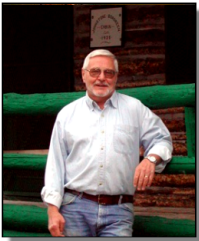

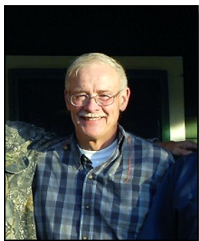

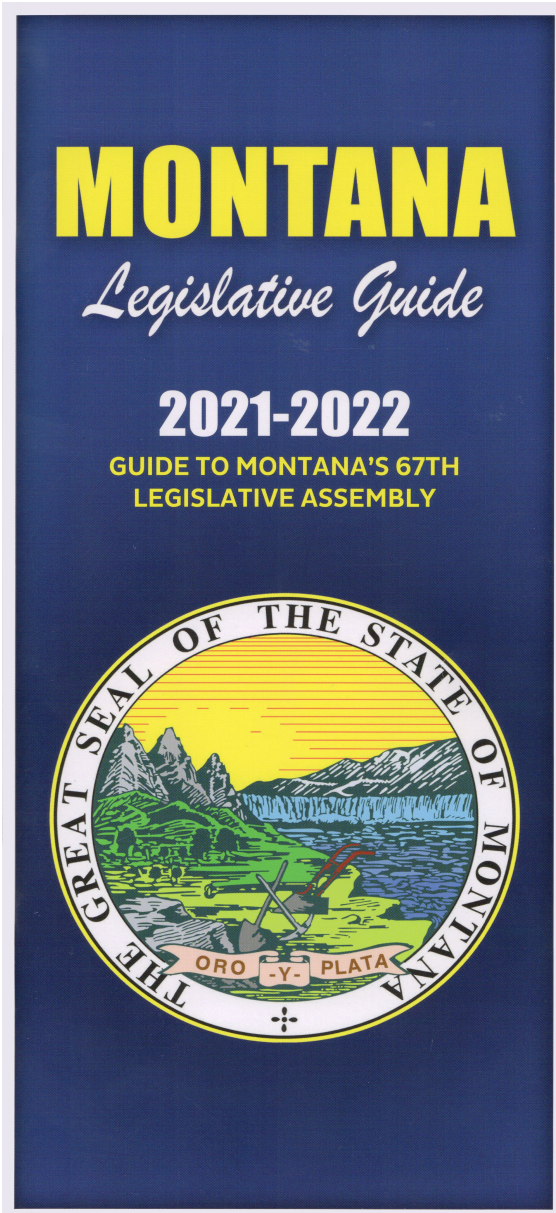

2021 Legislative Session

Methodology: Since 2015, MSA has been producing a legislative scorecard. The MSA Leadership Team chooses the bills we would like tabulated. We generally include bills we support and oppose, but this year all the bills were opposed. MSA then hires Kathryn Q. Kern to build the matrix and fill in the data. No one knows the end result until the tabulations are finished.

We are officially non-partisan. We will endorse folks from any party if they share our philosophy; and are committed to work for the benefit of Montana Resident sportsmen/women; and the long-term conservation of public trust resources.

We have a policy of “no federal lands transfer”. We will not endorse any candidate who advocates a federal lands transfer position.

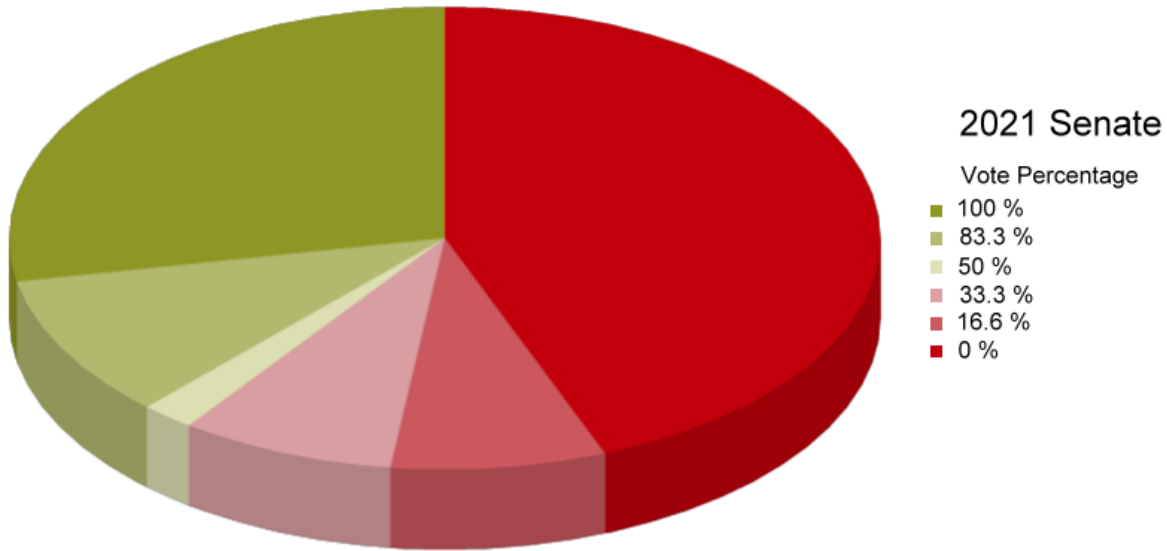
There are a number of points gleaned from our scorecard. We have 15 legislators that scored 100%, 14 Senators and 1 Representative, all across Montana. This year, the 100's were nearly even between the genders; 8 women to 7 men. We have 57 0's this session, more than double previous scorecards of the past. This statistic shows a huge and disappointing trend.

We hope the MSA scorecard will be valuable tool for voters when the next elections come around.

MSA Bill Summary

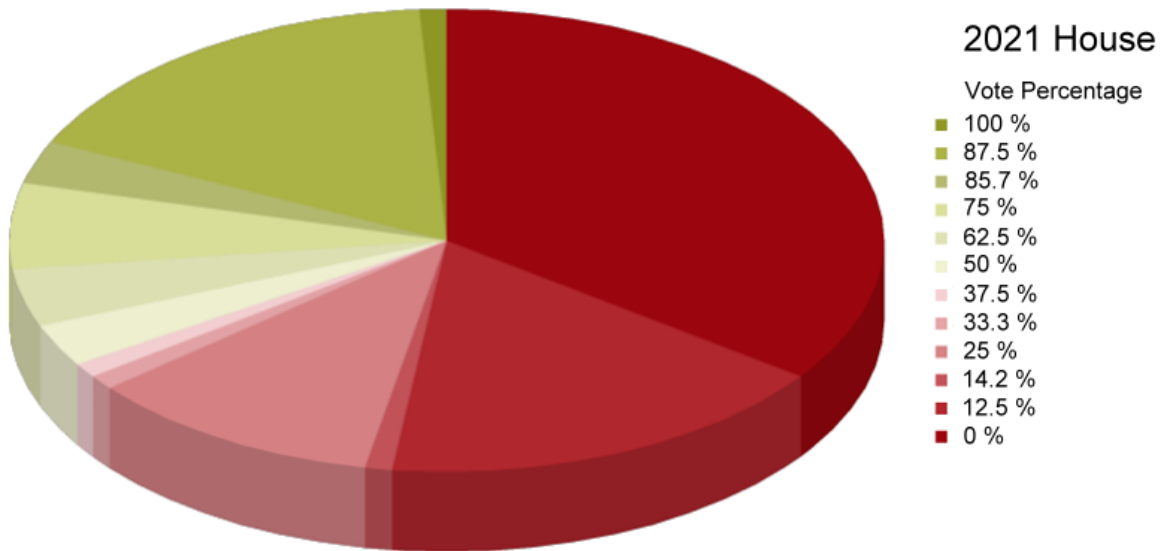
<p>HB 320 – Oppose Prohibit sales of federal land transferred to Montana. Language for the bill was boilerplate language created by the American Lands Council, which seeks to transfer federal public lands to the states.</p>	<p>SB 111 – Oppose The Bad Actor Crossbow Bill Revising laws re conditional hunting permits for disabled persons (crossbows) Description: Allows use of crossbow for persons with disability during archery season – Although, this opens the door for people claiming to be disabled.</p>
<p>HB 637 – Oppose \$1M spending authority to construct and operate a pheasant hatchery at the MT State Prison using the Upland Game Bird Enhancement Program. Allows FWP wardens to take a vehicle into possession if abandoned on state land, strikes no more than two Class D-4 (hound hunting) licenses may be issued in any one hunting district per license year, gives wardens the power of peace officers in the enforcement on some private and state lands, changes the percentage calculation based on an average that FWP uses to determine bonus points for nonresident elk and deer licenses, changes the nonresident class D-4 hound handler fee from \$500 to \$250 for mountain lions, increases the number of D-4 licenses from 35 to 50, adds in language similar to that found in 505 "is a nonresident landowner who owns 640 or more contiguous acres. Non-paying guests of the nonresident landowner may also hunt and pursue mountain lions on the landowner's property and any adjacent public land without a Class D-4 license" Strikes when licenses for bear and mountain lion need to be available for purchase, mandates shooting preserves must keep records, prevents flushing game birds with a vehicle and boat.</p>	<p>SB 115 – Oppose Land Board - Puts all conservation easements under the land board. Notes: Undermines Habitat Montana, priority of Sporting Coalition. Amendment moved thresholds for easements to \$1M. Fee title lands also were increased from 100 to 500 acres, and from \$100K to \$1M.</p>
<p>HB 695 – Oppose Generally Revise Environmental Laws Original text would allow agencies to charge folks who want to provide public comment on EIS.</p>	<p>SB 143 – Oppose Generally, revise laws re Class B-10 and Class B-11 elk and deer licenses Description: Bill reserved 60% of B-10 and B-11 licenses for nonresident hunting with an outfitter. The bill was amended to eliminate that dedicated percentage and replace it with an early draw, allowing up to 40% of licenses to be available through an early bird drawing with a fee of \$300.</p>
<p>HB 697 – Oppose Reimburse Landowners for Crop Damage by Wildlife Attempts to destroy the Habitat Montana program by pillaging it to pay crop damage claims in many hunting districts. The bill would establish a crop damage program and use it for claims, but only in districts that are double the objective number for elk. And it would apply in districts that have limited permits for bulls or bucks, which includes many parts of the Missouri River Breaks and southeastern Montana.</p>	<p>SB 275 –Oppose Generally revise the board of outfitters and outfitting laws and enforcement This bill would revise four laws currently under the authority of the Board of Outfitters. It would 1) revise the makeup of the Board of Outfitters; 2) would remove the law stating that records need to be submitted to the Board of Outfitters; 3) would allow for the partial sale or temporary transfer of a hunting or fishing outfitter's business; and, 4) remove the double adjudication of violations from the Board of Outfitters.</p>
	<p>SB 306 – Oppose Revise structure of fish and game commission Description: Expands FW Commission to seven, realigns commissioners with FWP managing regional administration districts, mandates at least 2 (was 4) commissioners must be landowners that are agriculture / timber producers, Gov to appoint Jan. 2022.</p>

1.	HB 320	Steve Gunderson, (R) HD 1	<u>Prohibit sales of federal land transferred to Montana</u> , Died in Standing Committee (S) 4/29/2021. OPPOSED: MSA opposed American Lands Council boilerplate language.
2.	HB 637	Seth Berglee, (R) HD 58	<u>Generally revise fish, wildlife, and parks laws</u> , Signed by Governor 5/14/2021. OPPOSED: MSA opposed outfitter and non-resident freebies; allowing non-paying guests of a nonresident landowner to hunt their land and adjacent public lands without a license for chasing lions with hounds; included spending authority to build and operate a pheasant hatchery at the state prison; robs money from the Upland Game Bird Program.
3.	HB 695	Denny Loge, (R) HD 14	<u>Generally revise environmental laws</u> , Died in Process (S) 4/29/2021. OPPOSED: MSA opposed allowing agencies to charge for public comment on EIS.
4.	HB 697	Joshua Kassmier, (R) HD 27	<u>Reimburse landowners for crop damage by wildlife</u> , Died in Process (H) 4/29/2021. OPPOSED: MSA opposed attempt to destroy Habitat Montana by using fit to fund crop damage.
5.	SB 111	Brad Molnar, (R) SD 28	<u>Revising laws re conditional hunting permits for disabled persons</u> , Died in Standing Committee (H) 4/29/2021. OPPOSED: MSA opposed attempt to get crossbow use into the bow season. Self-serving sponsor.
6.	SB 115	Keith Regier, (R) SD 3	<u>Establish acquisitions requiring land board consideration</u> , Signed by Governor 04/8/2021. OPPOSED: MSA opposed putting all conservation easements under land board. Some members of land board are guilty of playing partisan politics with decisions.
7.	SB 143	Jason W Ellsworth, (R) SD 43	<u>Generally revise laws re Class B-10 and Class B-11 elk and deer licenses</u> , Died in Process 4/29/2021. OPPOSED: MSA opposed attempt by outfitters to reserve 60% of licenses for nonresidents using an outfitter.
8.	SB 275	Jeffrey W Welborn, (R) SD 36	<u>Generally revise the board of outfitters and outfitting laws and enforcement</u> , Signed by Governor 4/22/2021. OPPOSED: MSA opposed revision of Board of Outfitters to eliminate public involvement; remove record keeping for outfitters.
9.	SB 306	Mike Lang, (R) SD 17	<u>Revise structure of fish and game commission</u> , OPPOSED: MSA opposed “stacking the deck”, unbalancing the commission with landowners.
